Precise measurements are essential to ensure the best possible fit. Please provide accurate and detailed information when submitting measurements.

Non-DUI add-ons, aftermarket accessories, or third-party modifications are not covered under DUI's warranty.

Measurements must be taken by an authorized DUI dealer or representative. Self-measurements or measurements taken by non-authorized individuals will void the fit guarantee.

Mobility and Health Considerations

Please discuss any mobility or health concerns (e.g., prior shoulder surgeries, joint issues) with your dealer. These considerations may require adjustments during suit construction.

Delivery Dates

Delivery dates provided by DUI are estimates and cannot be guaranteed. DUI will make every effort to meet the estimated delivery date, but unforeseen circumstances may cause delays.

The DUI Fit Guarantee is based on the DUI Guidelines for proper suit fit. Our suit patterns are designed to ensure a full range of motion for divers, accommodate minor weight fluctuations, and align with the undergarment specified by the customer on their order form.

Select Suits & Select Plus Suits

DUI does not guarantee the fit of Select suits, including socks or boots.

Alterations to a Select suits are the responsibility of the dealer and/or end user.

Select Plus alterations are made per customer and dealer specifications. DUI does not guarantee fit for Select Plus suits.

Signature Suits

Upon receiving your new DUI drysuit, please:

- Try on the drysuit while wearing your intended divewear underneath.
- Ensure a full range of motion
- Complete this fit check with an authorized DUI dealer. If the suit is not tried on before leaving the dealer's location, you are accepting the fit.

Fit concerns must be reported within 30 days of receiving the suit.

Standard placements for inlet valves, exhaust valves, pockets, p-valves, and other accessories are established by DUI. Any request to alter these placements must be specified on the DUI order for before manufacturing. Any changes after the suit has been constructed will come at a cost.

Important: Do not dive or trim seals if there are fit issues. If the suit has been used (dived), any subsequent fit adjustments may incur additional costs.
